





Business Qualifications

Prospective suppliers must meet certain qualifications to do business with Grange

- <u>Financial Stability</u> must have a good credit rating and provide a stable financial report
- <u>Insurance Requirements</u> (see next slide)
- <u>US Federal Taxpayer ID</u> must provide this number to Grange
- Quality Standards must provide high quality products and professional services competitive within the industry
- <u>Competitive Pricing</u> must offer prices that are competitive within the industry
- <u>Background checks on employees</u> must perform background check and drug screens on employees before doing business with Grange
- <u>Compliance with Grange's Travel Policy</u> must comply with Grange's travel policy for reimbursement
- <u>Legal Counsel</u> must provide Grange with quick access to legal counsel
- <u>Legal Title</u> must have legal, marketable title to all products and services offered

Insurance Requirements

- Supplier, its employees, agents, third-parties or other affiliated individuals shall at their expense maintain in full force and effect throughout the term of the Agreement insurance coverage with a carrier
 - Workers' Compensation: Statutory Compliance
 - Employer's Liability: \$500,000.00 per occurrence, or the minimum required by law
 - o Comprehensive General Liability (Bodily Injury and Property Damage): \$1,000,000.00
 - Comprehensive Auto Liability (Bodily Injury and Property Damage) (Owned and Non-Owned): \$1,000,000.00
 - Professional Errors & Omissions: \$1,000,000.00
- Rated at least A by A.M. Best
- Authorized to do business in the states where services are performed
